DECISION

Under s. 68 (1) (f) and (3), s. 58 (4) and (5) of Act No. 111/1998 Sb., to regulate higher education institutions and to change and amend other laws ("**the Higher Education Act**"), in conjunction with Article 33 (1) (c) of the Constitution of Charles University in Prague, and following Article 1 (5), 2 (4) and Article 12 paragraph (b) of Appendix No. 6 to the Constitution of Charles University – Fees for Study, the Dean of Faculty of Law of Charles University ("**the Dean**") has decided on the fee for study in a foreign language of: Jalal Naji, née 17.05.1976 in Doha, residing at 194 A Zahran str., 815 303 Amman, Jordan, a student in the doctoral study programme "Theoretical Legal Science", subject-area "International Law" organised in the English language at Faculty of Law

as follows:

The student shall pay the fee connected with study in a foreign language in the above specified study programme and subject-area conducted in the English language. The fee has been set in the amount of CZK 130,000 for the academic year 2016/2017, commencing on 1st October 2016. The fee is due on 31st October 2016 and shall be paid via bank transfer to the bank account of Faculty of Law of Charles University,

Reasoning:

Under s. 58 (4) of the Higher Education Act, as amended, a study programme in a foreign language organised by a public university may be subject to a fee for study in a bachelor's, master's or doctoral study programme, and also to a fee for acts connected with the

admission procedure; subsections (1) – (3) do not apply to the process of setting fees connected with study. Under s. 58 (8) of the Higher Education Act, generally binding regulations governing fees do not apply to fees connected with study determined in compliance with ss. (1) – (4).

Under s. 58 (5) of the Higher Education Act, a public university will determine and publish the amount of fees connected with study for the upcoming academic year on its website open to the public, no later than on the last day of the period set for filing applications for study; if the university determines and publishes the amount of fees for the upcoming academic year later, it may not charge students admitted to study commencing in the upcoming academic year, higher fees for study in the upcoming academic year than those applicable in the academic year in which the application was filed. Rules for assessment of the fee, mode of payment and due date are stipulated in the Constitution of a public university.

In compliance with s. 52 (2) of the Higher Education Act, the Rector of Charles University determined, through Rector's Measure no. 3/2016 – The Schedule of Academic Year 2016/2017 of 8th February 2016 (**"the Rector's Measure"**), that the commencement and closing dates of academic year 2016/2017 be 1st October 2016 and 30th September 2017 respectively.

Under Appendix 1 to the Higher Education Act, Charles University is a public university which organises the doctoral study programme "Theoretical Legal Science", subject-area "International Law" in a foreign language (in this particular case in the English language).

On 1 October 2015, the student enrolled in the doctoral study programme "Theoretical Legal Science" at the Faculty of Law, which is conducted in the English language, whereby he became a student of the faculty in the meaning of s. 61 (1) of the Higher Education Act. The student is enrolled in the 2nd year of study as of 1. 10. 2016.

The amount of fees for study in a foreign language for academic year 2016/2017 has been published on the website of Charles University, open to the public in compliance with s. 58 (5) of the Higher Education Act; the amount of fees has been determined pursuant to Article 33 (1) (c) of the Constitution of Charles University in Prague (**"the Constitution"**), under which the amount of fees connected with the organisation of study programmes in a foreign language is stipulated in Appendix No. 6 to the Constitution – Fees for Study (**"Appendix No. 6"**). Under Article 1 (5) of Appendix No. 6, the amount of fees for study in a programme conducted in a foreign language pursuant to s. 58 (4) of the Higher Education Act for each commenced year of study, is stated in Article 12 of the Appendix.

Therefore, Charles University is obliged, by virtue of office, to determine a fee to be paid by a student for study in a foreign language.

The amount of the fee set under Article 1 (5) and Article 12 (paragraph (b)) of Appendix No. 6 is in this particular case, i.e. the doctoral study programme organised in a foreign language at the Faculty of Law of Charles University, CZK 130,000. This amount, applicable to academic year 2016/2017, has been duly published on the official notice board of Charles University in compliance with s. 58 (5) of the Higher Education Act.

All conditions for setting the study-related fee, i.e. the fee for study in a doctoral study programme organised in a foreign language pursuant to s. 58 (4) of the Higher Education

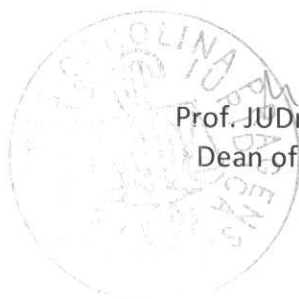
Act, have been satisfied; therefore, a duty is hereby imposed on the student to pay the study-related fee for study in the programme taught in a foreign language, determined under s. 58 (4) of the Higher Education Act , Article 1 (5) and Article 12 (paragraph (b) of Appendix No. 6.

The fee has been set for the commenced academic year of study, i.e. for the commenced academic year 2016/2017.

Under Article 2 (4) of Appendix No. 6, fees referred to in Article 1 (5) of Appendix No. 6 are due on the last weekday of the calendar month in which the given academic year commences; therefore, the Dean set 31st October 2016 to be the due date of the fee connected with study in a foreign language.

Notice:

This decision may be appealed within 30 days of it being announced. *The period for lodging an appeal starts to run on the day following the day on which a copy in writing of the decision was served on the student; where the undelivered copy of a decision has been deposited to be picked up by the student, the period will start to run after 10 days have passed since the day on which the undelivered, deposited decision was made available to be picked up by the student.* The appeal should be addressed to the Dean of the Faculty of Law of Charles University, and submitted at the following address: Faculty of Law, Nám. Curieových 901/7, 116 40 Praha 1. The Rector is the authority designated to dispose of the appeal.
