- **For non-native speakers** proof of competence in the English language (TOEFL etc.) at **B2+ level**, unless you carried out your previous university studies predominantly in the English language
- **Curriculum Vitae**
- List of previous **scientific publications** (if applicable)
- **Confirmation of the payment** of the non-refundable application fee of **200,- USD** (to be paid prior to the date of application)

Full tuition fee payable upon receiving acceptance letter is **6 950 USD** per programme
