

**LL.M. COURSE
LEARNING AGREEMENT**

**ACADEMIC PERIOD OCTOBER 2013/FEBRUARY 2015 – CHOSEN
SPECIALIZATION:**

**Charles University in Prague, Faculty of Law (nám. Curieových 7, 116 40 Praha 1, IČ:
00216208), hereinafter referred to as the “Faculty”, represented by its
Dean Prof. JUDr. Aleš Gerloch, CSc.**

and

**Mr./Ms. Name, Address, Nationality, ID (passport), hereinafter referred to as the
“Candidate”**

agree to the following Learning Agreement on the LL.M. course:

Article 1

Upon satisfying the admissibility criteria the Candidate is admitted to the LL.M. course by the Letter of Admission together with this present Learning Agreement signed by both parties. The admission is made conditional upon payment of the admission fee of USD 6.000,- (six thousand US dollars).

Article 2

The LL.M. course shall be carried out in compliance with its academic schedule within period of 3 semesters from its commencement. First two semesters shall be done in form of on-site study with regular attendance to classes on daily full-time basis. The third semester may be done in form of distance study with limited presence at the Faculty.

Article 3

Over the period set out in Article 2 of this Agreement the Candidate is obliged to earn at least minimum of 60 ECTS credits through course work (first two semesters) and additional 5 ECTS credits through completion of Diploma Seminar given in Prague and 25 ECTS credits through submitting Thesis of minimum of at least 50 pages written double-spaced and its defense in person in front of a committee (third semester).

Article 4

Total of 40 ECTS credits must be obtained by successful completion of courses mandatory for all candidates (each for 8 ECTS credits). 20 ECTS credits must be obtained by successful completion of optional courses (each for 5 ECTS credits). The list of mandatory and optional courses is given separately and might be subject to changes.

Article 5

The list of optional courses chosen by the candidate according to the published list of currently available courses is attached to this Learning Agreement and forms an integral part thereof (Annex 1). It may be modified within three weeks after the beginning of each semester (Annex 2). The provisions of Articles 3 and 4 remain unaffected.

Article 6

Successful completion of each particular course is subject to attendance of at least 80% of classes and complying with requirements set out by tutor of each particular course. Successful completion of the Diploma Seminar requires attendance thereof. The Thesis shall be successfully defended in front of a committee composed of at least 3 academicians.

Any assignment requiring elaboration of a written paper (Thesis, essays etc.) must fulfil academic requirements as to its originality, rules of citations and avoidance of plagiarism. Plagiarism may result in refusal of such paper for further evaluation and/or termination of Candidate's participation in the LL.M. course without the right to reimbursement of tuition fees already paid.

Failing to meet the requirements set out by this Learning Agreement for the LL.M. course in general and the requirements set out for successful completion of each particular course shall result in termination of participation in the LL.M. course without conferral of the LL.M. degree and without right to reimbursement of tuition fees already paid. In case of each exam there is a possibility of two retakes in case of failing the exam.

Article 7

The Candidate shall be awarded with the internationally recognized title of LL.M. (Master of Laws/Magister Legum) upon successful completion of the LL.M. course in compliance with conditions set out by this Learning Agreement, Dean's Provision No. 9/2011, Rector's Provision No. 5/2011, s.36a(3) of the Statute of the Charles University in Prague, and s.60a(2) of the Higher Education Act No.111/1998 Coll. This title proves expertise of the Candidate in the field of the respective Specialization. Under the applicable provisions of the Czech Law it does not substitute the academic title of Magister (Mgr.) provided for in s.46(4)(g) of the Higher Education Act, which is an indispensable precondition for entering regulated legal professions in the Czech Republic.

Article 8

Upon request of the Candidate the Faculty will provide assistance with reservation of an adequate place in a dormitory of Charles University in Prague. The candidate is always responsible for covering all of his/her living expenses during the whole period of enrolment in the LL.M. course.

Article 9

The Faculty does not assume any responsibility for other than academic activities of the Candidate prior, during or after his/her stay for purposes of LL.M. course in the Czech Republic.

Article 10

The legal relationship between the Faculty and the Candidate shall be governed by this Learning Agreement, Statute of the Charles University in Prague, legal acts adopted in compliance with this Statute, and applicable provisions of the legislation of the Czech Republic.
